



In case of any complaint/inspection in future, if the fact comes to light that the application has been given to the government on the basis of wrong information while obtaining the No Objection Certificate or the instructions issued by the Punjab Government from time to time have not been followed by you is made and the written conditions given in such affidavit are not complied with in such case this No Objection Certificate can be withdrawn at any time.

- Teaching of Punjabi in your school will be compulsory till Tenth standard and CBSE New Delhi will make efforts to conduct Punjabi examination in such schools and it is also said that in case of not doing so the No Objection Certificate will be withdrawn forthwith.
- The school management education department will strictly follow the notification issued by the Punjab Government under RTE Act 2009 and the rules of RTE Act 2009 made for the State of Punjab.
